For 1911, Massachusetts Homeopathic Hospital had a death percentage of 3.4.

Comparative percentage of cures of the insane:

In ten allopathic hospitals for the insane, the percentage of cures in all cases admitted (on the authority of the Report of the State Board in Lunacy for the State of New York) as 23.92. In the Westboro State Homeopathic Hospital (Mass.) for five years ending March, 1909, the percentage of cures was nearly double this figure—46.31. In Middleton State Homeopathic Hospital (N. Y. State) during the last five years it was 40.31. In three other Homeopathic hospitals the rate ranges for recent periods from 32 to 45.53 per cent.

THE ARROGANCE OF THE RICH

Any irreverent reference to the rich always makes Harper's Weekly peevish. A surgeon recently wrote to the New York Times explaining why fees differed according to the financial status of the patient; incidentally he drew attention to the well known fact that millionaires do not usually pay their medical attendants graciously. He wrote dispassionately, for letting go of money with pain and difficulty is characteristic of those who have acquired it; it is an essential qualification of the unlovely acquisitive class. Notwithstanding the writer's moderation, Harper's Weekly hurries to point out to him that he obtained his medical education through the charity of the rich; and that a more reverent attitude toward the wealthy would be becoming.

The medical profession hardly feels indebted to the rich, be they so at first hand, or through inheritance. It is the piggishness of capital that gives rise to most sickness, to typhoid epidemics, to tuberculosis, to the industrial accidents that demand surgical intervention. Capital could clear the country of malaria, and of disease and accident generally. We do not ask this of capital; we demand it of the State. Still this characteristic tone of the distinguished reactionary weekly is better perhaps than its approval, which a great statesman fortunately begged it to withdraw from him.

We might—we will, indeed, some day—induce the State to endow professorial chairs, which are now needed more than the gorgeous buildings to the erection of which private capital insists, for obvious reasons, on devoting itself. Meanwhile private capital might extend scientific help to the blind, the crippled, the underdeveloped, and the starving, mostly victims of wealthy selfishness; it could help such to help themselves. Indeed it is beginning to heed protests that are no longer accompanied by a respectful touching of the cap.—New York Medical Journal.

THE CASE AGAINST THE VACCINES AND SERUMS

The promoters and chief beneficiaries of the vaccine and serum craze are the manufacturers. The manufacturers have secured the services of fluent and plausible writers to place the alleged merits of serums and vaccines before the medical profession, they have collected literature favorable to their use, have discouragd the publication of fatalities resulting from the use of vaccines and serums, and in all instances have sought to explain fatalities, and minimize the dangers resulting from the use of vaccines and serums. This is not exactly a scientific precedure, but it is a good prime commercial scheme, and it sells the goods and pays dividends.

The craze for bacterial vaccines and serums has reached its height. The reaction against their use by careful, and conservative medical men is setting in very strong. The Journal of American Medical Association in a recent issue has this to say: "The therapeutic possibilities of vaccine therapy have been exagerrated. The promiscous use of the stock vaccines of commerce in the treatment of acute and chronic infections is an irrational procedure. Ready mixed commercial vaccines should be abolished." Prof. Ehrlich recently said "The possibilities of serum and vaccine have been exhausted."

Vaccines are dangerous and deadly in their action. Vaccines are prepared by mixing bacteria from different sources, from different individuals, who are suffering from the various diseases caused by the different bacteria. In other words to state it plainly the filth and disease germs from different persons are mixed together and given to healthy persons on the presumption that the bacteria so given or injected will prevent or cure the diseases caused by such germs, or bacteria. The bacteria are "killed" so the manufacturer tells us, hence the bacteria can do no harm. The effect desired and expected is simply to arouse nature to throw off certain diseases. If the bacteria are "killed" the peculiar and characteristic action of the bacteria is wanting, and the action of the injected mixture is purely that of a filth poison which the body processes seek to expel. Why not use a sterilized mixture from a garbage can or sewer?

On May 20, 1914, The Cincinnati Times-Star publishes a special dispatch from New York City which stated that three healthy children by the name of Mercer aged ten, six, and five years, respectively, received typhold vaccine furnished by the Department of Health of New York City. Their father was sick with and died later of typhoid fever. Within a few hours after the injections were given to the children they all become ill, their legs became weak, and began to swell. Dr. Sydney E. Smith who administered the serum (vaccine) called Dr. George E. Laidlow in consultation. The children grew rapidly worse. Dr. Smith said they had typhoid symptoms and also showed effects of blood poisoning, in body markings. He informed the mother that the condition of childhen was hopeless.

They insist the bacteria are "killed." The Mercer children showed the symptoms of typhoid fever within a few hours after the injections of the vaccine. The Mercer children also showed symptoms of blood poisoning. Here is a clean cut typical case which shows that the so-called "killed" bacteria are active and will cause typhoid fever, that the vaccines are dirty filth and will produce blood poisoning. These Mercer children were presumably healthy, happy, normal individuals. There was nothing to show that they would contract the disease. They were given no chance, but were inoculated with typhoid poison so they would not contract a disease which under Homeopathic treatment has an extremely low percentage of mortality. The active disease resisting functions of the body would, in all human probability, have prevented these children contracting typhoid fever, but they were deliberately inoculated and poisoned. It is time scientific and conscientious physicians protested against such barbarous, and inhuman work. It is a disgrace and a reproach to the medical profession who practice, tolerate, or permit it.

In the great majority of cases where vaccines are given there is fever, weakness, irritation, and often sudden death. This shows the poisonous effect of the vaccines. It also shows that a poison has been introduced into the body and the body is making tremendous effort to expel it.

Dr. Charles E. Woodruff, Lieutenant-Colonel, retired, of the United States Army Medical Corps and said to be one of the greatest sanitary experts in the world, in a magazine section of the Daily

Examiner, says: "The whole theory of vaccination and serums is It insures us against catching one disease only to make us doubly liable to catch others, particularly tuberculosis." Dr. Woodruff goes on to say human beings have a natural resistance to tuberculosis, and with ordinary care in preventing or developing causes, will fight off the plague through a lifetime. Though the use of vaccines and serums the body is robbed of a part or all of its natural immunity to disease. or resistance and culosis developed. where it. would not develope the vaccine inoculation. Woodruff quoted Dr. LeTulle of Dr. "That all serums and vaccines will cause incipient Paris. France: cases of tuberculosis to get worse, and this opinion is concurred in by Drs. C. H. Spooner, and Louis and Combe, assistants to Vincent at the Val de Grace, Paris. Chantmerse of Paris warns against the use of vaccines where tuberculosis is suspected.

Serums owe most of their popularity to Anti-Diphtheritic serum. The horse is inoculated with Diphtheria, and the diluted and sterilized serum from the horse's blood, is the foundation for the Anti-Diphtheritic serum. Its use came about by the discovery that the horse was immune to the deadly effects of diphtheria, and it did not kill the horse when he was inoculated with the poison of diphtheria. Pure serum properly sterilized from the blood of the horse is also used for certain diseases. Even though the horse is immune to diphtheria it does not necessarily follow that the horse serum impregnated with the modified horse diphtheria will always render human beings immune to diphtheria, or modify and cure the developed dis-To oppose one poison (toxin) with another poison (toxin) which has the serum of the horse's blood added is a dangerous and unscientific experiment. The resistant power of the body afflicted with diphtheria is already rallying all its strength and resources to rid the individual of the immense amount of poison (toxin). folly to add more diphtheritic poison (toxin) to body already well nigh overwhelmed. In thirty-five years' practice I have seen many children killed with Anti-Diphtheritic Toxin, and both before and since the use of Diphtheritic Toxin I have seen more cases recover from Diphtheria under Homeopathic treatment without Antitoxin than under Antitoxin. If the horse serum gives the horse immunity

to diphtheria it would be far better practice and decidedly more scientific and reasonable to give persons afflicted with diphtheria the pure horse serum undefiled with poison. It is my opinion, and the conclusion is justified by all the facts, that all the merit and efficacy of Antitoxin for diphtheria, if it ever does good, lies wholly in the immunizing effect of the pure horse serum alone. If the horse serum alone and unaided confers immunity upon the horse to diphtheria, it is certainly a grotesque and amazing thing to add the terrific filth poison of diphtheria to pure horse serum on the guess that this filth and poison will somehow and in some unknown and marvelous way cure diphtheria in human beings. The whole proposition is ridiculous and will not stand analysis.

Following the use of anti-toxin for diphtheria a flood of serums and bacterial vaccines have appeared. There is no other animal beside the horse which is immune to disease in the same manner, hence to conclude that serums modified and made through other animals will be efficacious is not borne out by the facts.

The Antimeningitis Serum is injected into the lower portion of the spinal canal after an equal quantity of the spinal fluid is drawn This serum is extremely uncertain and deadly in its action and has caused many deaths. Dr. S. P. Cramer an eminent Surgeon of Cincinnati, former U. S. Army Surgeon, and recently President of the Cincinnati Academy of Medicine, and Professor in the University of Cincinati, made the following report to Mr. E. J. Lederle, President of the Board of Health of New York City, "The Board of Health of the City of New York prepares and distributes a serum for the treatment of cerebro-spinal meningitis." "On Monday, May 17, 1913, I reported to the Academy of Medicine of Cincinnati six cases in which death by respiratory paralysis had occurred in a few minutes following the administration of this serum. I reported two other cases in which respiratory failure had followed the injection; breathing was revived by artificial respiration. these cases occurred in children."

"On March 21, 1913, the Director of the Rockefeller Institute, in a statement to the Associated Press, said: "If the anti-meningitis serum itself, or the preservative contained in it, were the cause of the deaths reported by Dr. Kramer of Cincinnati many other similar reports should have been received; but such fatalities have been reported by no one else."

"In the U. S. Public Health reports, January 26, 1912, on page 115, Dr. W. H. Frost, passed assistant surgeon U. S. Public Health and Marine Hospital Service, has described such deaths. In the Journal of the American Medical Association of March 1, 1913, page 959, Dr. Arthur H. Parmalee reports ten cases of respiratory paralysis. Indeed so common has this catasthrope become, that a circular issued by your department, and a copy of which I am enclosing, directions are given as to what should be done when breathing stops, following the injection."

These cases and statement speak for themselves.

After Dr. Flexner of the Rockefeller Foundation (old school or allopathic) had reported a death rate of 15 per cent from Cerebro-Spinal Meningitis, the New York Health Reports show 372 cases of Cerebro-Spinal Meningitis with 336 deaths, a mortality of over 90 per cent, and that right under the shadow of the Rockefeller Foundation.

Homeopathic Treatment can show a much lower mortality from Cerebro-Spinal Meningitis without the serum.

The mixtures known as Salvarsan and Neo-Salvarsan put out by a German physician for the treatment of syphilis have for their principal ingredient arsenic. The theory of the treatment is to flood the system of the diseased person suffering from syphilis and so drive out the blood poison.

On March 7, 1914, in the County Hospital at Los Angeles, California, eight patients died immediately after receiving one dose each of Neo-salvarsan mixed with the individual blood serum of each patient. Two other patients escaped because there was not time to prepare their doses. Lucky patients. In all of these cases as in the cases of deaths from antimeningitis serum death was due to paralysis of respiration and the nerve centres. What caused these deaths? The Eclectic Medical Journal of Cincinnati for April, 1914, page 215, says editorially: "Perhaps the mortuary records in these cases will be inscribed G. O. K. which signifies "God Only Knows." But why use preparations, with but doubtful expectation of relief, that require such extremes of cautious manipulation and that are liable,

even if innocuous when first prepared, to become deadly by some swift and magic like change?" Does anyone recall wholesale deaths from any such changes taking place in standard vegetable medicines long recognized as safe and effectual in disease?" Let something novel come from Germany, however, with loud acclaim of wonderful possibilities and America seizes upon it with astounding avidity—in the end to regret her rashness. Dr. Solomon Solis-Cohen recalls such a record of a German coal-tar product, when in speaking in a paraphrase of the song of the Jewish women when Saul and David returned victors over the hosts of the Phillistines: "Influenza has slain its thousands, but antipyrin its tens of thousands." When the census of deaths from intra-spinal and intravenous injections will have been completed we predict that the record will compare favorably (or unfavorably) with that of the imported synthetic analgesies and febrifuges.

In an article on "Why Vivisection," in the April Cosmopolitan, there appears the following:

"Take Diphtheria and Antitoxin for instance. The mortality percentage has never been as low for antitoxin as it has been for other remedies. Dr. Newman, of Potsdam, found that in his private practice, without serum there was an average of only 1.6 per cent mortality, as against 15.4 per cent in the city infirmary where serum treatment was used. Leuddecken, using cyanide of mercury, reported a mortality of 1.2 per cent. Hilol and Goubeau, employing per chloride of mercury report a mortality of 4.7 per cent. Kastorsky, using an alcoholic solution of menthol, treated 37 successive cases without a death. The latest reports of Metropolitan Asylums Board, England, show: without antitoxin (in 583 cases) mortality 1.88 per cent; with antitoxin (in 4839 cases) mortality 10.18 per cent."

The mortality of diphtheria in the Homeopathic School of Medicine, where the above mentioned drugs have been used for many years, has never been as great as with antitoxin. If the case is seen early the disease is usually aborted.—Pacific Coast Journal of Homeopathy.

Antitoxin has killed its thousands. Antitoxin has killed hundreds of children suffering from mild cases of diphtheria. If these children had been treated with homeopathic remedies by a competent homeopathic physicians without antitoxin a large number would have been saved. Antitoxin should be consigned to the scrap pile.

SCIENTIFIC DEMONSTRATION OF HOMEOPATHIC MEDICINE IN BALTIMORE

Before a distinguished group of scientists in the Johns Hopkins Physical Laboratory, Dr. L. J. Henderson of Harvard University attested that there is power in attenuated homeopathic medicines of high potency, as it is sometimes called.

Dr. Henderson asserted that researches extending over many years convinced him that inorganic matter contained latent life. He added that he believed that under certain conditions this latent life could be aroused, but that infinitesmal attenuations rather than crude substances were necessary.—Pacific Coast Journal of Homeopathy.

Scientific men everywhere are bearing testimony to the efficacy of homeopathic remedies, and their value in curing disease.

This was a marvelous exhibition of scientific insight. Hahnemann knew the law of cure was true, and that the similar remedies to cholera would cure them. of this prophecy and absolute confirmation of all his statements were made complete in several of the great world epidemics of cholera.

Osler, in his Practice of Medicine, page 232, gives the mortality from cholera under allopathic or old school treatment as 30 per cent to 80 per cent. Allbutt's system of medicine, Vol. 1, page 908, gives mortality from chodera under allopathic or old school treatment as about 50 per cent. Page 18 "Logic of Figures," (Dr. Bradford) Admiral Mordowinow, President of the Imperil Council of Russia, stated that in 1831-1832 the mortality under allopathic or old school treatment was 40 per cent.

The Homeopathic treatment of cholera shows the following mortality: Vide "Logic of Figures," Dr. Bradford, page 116 et seq Dr. Quin, London, reports mortality of ten Homeopathic Hospitals 1831-1832, as 9 per cent.

Dr. Roth, an allopathic physician to the King of Bavaria, reported

officially and with great reluctance, that the Homeopathic mortality in 1831-1832 was 7 per cent.

Report of Hahnemannian Academy of Medicine showed that in New York the mortality from cholera was 6 per cent in 1849.

Page 118 idem op Admiral Mordinow, in same report, testified that the mortality of cholera under Homeopathic treatment was 10 per cent.

Page 136 idem op Joslin reports 4830 cases of cholera in three epidemics, 1831-1832, 1848 and in 1849, gave homeopathic mortality of 9.21 per cent.

Page 118 idem op, Dr. Wild, allopathic editor of the Dublin Quarterly Journal of Medicine, in his book on Austria, says "The allopathic death rate was 66 per cent from cholera. On account of this extraordinary result, the law interdicting the practice of Homeopathy in Austria was repealed, and the death rate of the same period Wild concedes was 33 per cent."

The mortality of cholera averaged all epidemics was under allopathic treatment 49.57 per cent while under Homeopathic treatment it was 16.83 per cent.

In the Hamburg epidemic of cholera, 1892 (see Handbook of Practice by Dr. C. J. Puhlman, page 526,) the allopathic mortality of cholera was 42 per cent. Under Homeopathic treatment the mortality raged from 15.5 to 20 per cent.

Historicai Note

In July, 1843, the New York Homoeopathic Physician's Society issued invitations to the homoeopathic physicians of the United States to meet in general convention in the city of New York for the purpose of forming a National Homoeopathic Medical Society. The invitation was responded to by a considerable number of the leading homoeopathic practitioners of the country, who, according to previous arrangement, convened in the Lyceum of Natural History in New York City, on the 10th day of April, 1844, the 89th anniversary of the birth of the illustrious Hahnemann.

The convention was organized by electing Constantine Hering, M. D., of Philadelphia, Pa., President; Josiah F. Flagg, M. D., of Boston, Mass., and William Channing, M. D., of New York City, N. Y., Vice-Presidents; and Henry Dunnell, M. D., Secretary.

The following resolution was unanimously adopted:

Resolved, That it is deemed expedient to establish a society entitled "The American Institute of Homoeopathy."

John F. Gray, M. D., was elected General Secretary of the Institute, and S. R. Kirby, M. D., Treasurer.

The Convention having accomplished the object for which it had assembled, on motion, adjourned, sine die.

Immediately after the adjournment of the Convention, on the evening of the 10th day of April, 1844, at the call of John F. Gray, M. D., General Secretary-elect, the First Session of the American Institute of Homoeopathy was held. Josiah F. Flagg, M. D., Boston, Mass., was elected Chairman, and A. Gerald Hull, M. D., New York City, N. Y., Provisional Secretary.

A memorial service was held in the Pittsburgh Homoeopathic Hospital December 14th for three members of the staff who had passed away during the past six months. Then men honored were Drs. J. H. McClelland, Z. T. Miller and E. R. Gregg. The ward was beautifully decorated with flowers. President D. G. Stewart, of the Hospital Association, presided. Following the prayer Mr. Stewart spoke concerning his associates in hospital work in a way which brought tears to the eyes of all present. Dr. C. C. Rinehart made an address, as did also Mrs. George L. McCoy, who for so many years has been secretary of the Ladies' Board of the hospital. Others speaking were Drs. H. B. Bryson, Pittsburgh, and Dr. Gilbert Palen, Philadelphia The service was one which will long be remembered by those present.
