A LAYMAN SPEAKS

The increasing cancer death rate discredits the surgery, x-ray and radium of orthodox medicine; and the "research" of the Cancer Societies. A recent estimate has it that one of every ten *now living* will die of cancer. This can be taken to mean that the orthodox medical men have no answer to the problem and that nothing is to be expected of them during the life-time of those *now living*, and that the "research" of the Cancer Societies will search in vain for a cancer serum. The constantly increasing death rate from Cancer, Anemia, Heart Disease and Polio and the physical wrecks from degenerative diseases challenge the layman to turn a critical eye on the medical treatment that fails and on the medical men who prescribe "wonder drugs" on the basis of manufacturer's propaganda. As to Cancer—"it is definitely a blood disease and

must be treated as such" (Dr. Robert Bell). Quoting Dr. W. A. Dewey, former Professor of Medicine, University of Michigan—"In a practice of nearly 45 years I have yet to see a single case of cancer cured by Surgery, X-ray or Radium". Logically and homœopathically speaking, the cancer is the person, the individual himself. The growth is the blossom and after the removal of it by surgery, or radiation, the cause remains to produce a recurrence. Official medicine insists that Surgery, X-ray and Radium are the approved methods of treatment and without consideration for relative merit they frown upon and persecute those who hold to different methods.

There is a scandal in the making over this. "Senator Charges American Cancer Society And American Medical Association Are Suppressing Cancer Cure" is carried on the front page of the *Christian Crusader*, issue of May 15, 1956, and from the article by the Editor, Rev. Merle E. Parker, D.D., the Senator's charges won't be too difficult to substantiate. The health and medical situation challenges the layman to do some serious thinking. We read and hear a lot about the "science of medicine" and "preventive medicine". But the flighty empiricism: bleeding, transfusions, typing pneumonia, sulphur drugs, wonder drugs in general, Virus X-Y-Z-, Types A-B-C- of this and that, these do not qualify as Science and the prescribing of drugs without knowing the secondary effect is quackery. It has been said, and it is logical to believe, that the person whose blood stream is clean and chemically adequate never develops Cancer. And it naturally follows that "preventive medicine," vaccination and inoculations, pollute the blood stream, and apart from the immediate danger of serum sickness and infection through materials carrying living germs, accidental or otherwise, has much to do in the development of degenerative diseases.
