1. *Diverticulum of bladder*

Dr. D. N., a retired Civil Surgeon, aged 74 years, suffered from retention of urine for some time. He was operated upon for enlarged prostate. But cystitis again developed and urine could be voided only through a catheter. The eminent surgeons of a prominent Medical College declared it a case of Diverticulum of bladder and said that no operation was possible. The patient was given a permanent catheter.

After about five months of this condition, the patient consulted me. He was treated for paralysis of bladder and on the totality of symptoms was prescribed *Causticum* 1m, once a fortnight. After only three doses the bladder began to function and the catheter was discarded. The patient has now been under homœopathic treatment, for over 8 months and has been progressing.

Homœopathy came to the rescue, where modern surgery failed.

2. *Blister in Soft palate*

A young man aet. 32 years had a peculiar trouble. After every meal, a blister like a pearl developed in the soft palate daily and disappeared after three hours.
