## AMENDED CONSTITUTION OF THE WEST BENGAL HOMOEOPATHIC STATE FACULTY

### CONSTITUTION:

The said Council shall consist of the following members, namely:—

- (a) A President; a Vice-President—nominated by the Local Government for the first term and subsequently elected by the members of the Council.
- (b) One member for every 250 electors excluding any fraction thereof to be elected by and from among the electorate of each of the two divisions of West Bengal, subject to a minimum of one for each Division.
- (c) One member, who may or may not be a practitioner in Homœopathic medicine, nominated by the Calcutta Corporation.
- (d) One member for every 250 electors excluding any fraction thereof to be elected and from among the Calcutta Electorate, subject to a minimum of one.
- (e) One member, who may or may not be a Homœopathic practitioner, nominated by the Calcutta University.
- (f) The Principal of each Homœopathic College which has attached hospital and which is affiliated to the Council according to the rules prescribed by Government and regulations framed by the Council with the approval of the Government.
- (g) Three persons to be nominated by the Provincial Government, one of whom shall be a member of the West Bengal Legislative Assembly.
- (h) One member who should be a Registered Homœopathic Practitioner, to be co-opted by the other members of the Council before the election of President and Vice-President.

Provided that pending the Constitution of a Council under this Section, the Provincial Government may appoint a Council consisting of such members and for such period

as it may think fit when for any reason a Council cases to exist.

Provided further, that the General Council and State Faculty of Homœopathic Medicine, approved by the Provincial Government, after the partition of the Province shall be deemed to have validly constituted under the Status.

N.B.—The above amended Statute of the General Council and State Faculty of Homœopathic Medicine was published in the *Calcutta Gazette* under Notification No. Medl. 523|3R—24|49 of the 26th November, 1949.

### ELECTIONS TO FACULTY OF HOMŒOPATHIC MEDICINE

The term of office of the nominated members of the General Council and State Faculty of Homœopathic Medicine, West Bengal will, states a Press Note, expire on June 30, 1950 and a general election of the Council will be held before this date according to the amended Statute published under Notification No. Medl. 5234|3R-24|49, dated November 26, 1949 and election rules published under Notification No. Medl. 5235|3R-24|49, dated November 26, 1949.

A preliminary voters' list in this connection has been prepared and will be available for sale and inspection at the office of the Council from April 10, 1950. Any objection regarding the said list should be notified in writing to the Returning Officer within April 24, 1950. No objection will be accepted after the above date, and final list of voters will be published by the Returning Officer after reviewing and scrutiny of the objection on April 30, 1950. No candidate will be allowed either to vote or stand as a candidate in this election, whose name does not appear in the final voters' list.

Election rules can be had on payment from the Government Press, Alipore, and voters' list will be sold from the office of the Council for Rs. 5|- per copy from May 1, 1950.
