A PEEP INTO THE LIFE OF DR. RAM PRASAD VERMA

Dr. Ram Prasad Verma, a true follower of Hahnemannian Philosophy and art of healing was born in the year 1890 at Patna City. His father was an ordinary cultivator. When a child he was sent to a Moulvi for primary education. When he gained some knowledge in Urdu and Persian he was admitted to a local High English School, from where he passed the Entrance Examination in the year 1909. After that he was admitted to the local Medical School, but after three years he had to leave that school due to some domestic troubles and to take up some private business, which he also gave up as he ran a loss. He then became a School teacher and began his private studies in Homeopathy. He passed the Homeopathic Medical Examination from the Bihar Homœopathic College in the year 1918 and was placed in the First Division. At that time Dr. Saffadar Hussain L.M.S. was the Principal of that 3

College. He then accepted an employment in the Arrah Jain Hospital, but he left that employment in the year 1921 and became an independent practitioner. In the year 1922 he started a Homœopathic College at Arrah in which he became a professor of Materia Medica and Practice of Medicine. One of his friends, Dr. S. N. Sircar, who was also an eminent Homœopath having a vast knowledge of Homœopathic Philosphy, was teaching there Homœopathic Philosophy and an Allopath was appointed as a professor of Anatomy and Physiology. This college worked properly up to 1937 but after that, the condition of the college grew worse due to two fold reasons. First that Dr. Sircar severed his relations with the college and secondly that Dr. Verma himself became such a busy practitioner that he got very little time to attend the college. This college was functioning under a board which consisted of the S.D.O., a Deputy Magistrate, and Vakils, Doctors and Zamindars as its

Dr. Verma himself was not very much satisfied with the progress made in the cause of Homœopathy. He wanted that the people should be Homœopathically educated through the medium of Hindi. At that time there was a scarcity of the Homœcpathic literature in Hindi and there was not a single book in Hindi which could be called a standard book. In order to meet this scarcity he wrote marky books on Homocopathy in Hindi. For the Homocoparas of Bihar as well as of India are very much indebted to him

When the Bihar Homœopathic Medical Association was founded in the year 1931, it was the Homoeopaths of the two districts of Gaya and Shahbad only that participated first in that Association with the efforts of Dr. Palit and Dr. Verma. It can, therefore, be safely said that Dr. Palit and Dr. Verma were the real founders of that Association. The first Conference of that Association was held at Gaya and the second at Arrah under the Presidentship of Dr. Paresnath Chaterjee, L.M.S. of Patna. The honoured

President of that conference was Dr. J. N. Mazumdar of Calcutta. Dr. Verma was the chairman of the reception committee of that conference and was the President of the Shahabad District Homœopathic Association. He held the office of the President, Shahabad District Homœopathic Association, up to the year 1939. In the year 1940 he was elected President of the Provincial Homeopathic Association held at Laheriasarai. He worked very hard in that capacity for one year. Till then the Provincial Homœopathic Association was not a registered Association. It was registered during the Presidentship of Dr. Verma. He was also the Chairman of the Provincial Bureau of Homœopaths in the Second All India Homœopathic Conference. He was elected as a delegate from Bihar for the 5th All India Homœopathic Conference held at Agra. He was also elected President of the Gaya District Homœopathic Conference held in a village named Guraru in the year 1939. When call came for a united effort for the uplift of Homeopathy in 1952, he at once joined the Bihar Homeopathic Science Congress. He remained a member of the Bihar Council of Homœopaths, and the State Executive of the Bihar Homæopathic Science Congress till his death.

As a successful physician he was known to every corner of the State of Bihar, as well as to its sister states. A number of times he was called to Chunargarh, Banaras, Mirzapur etc. for inspection and treatment of patients. Once he was called by wire for medical advice and treatment of Sir Sahebji Maharaj of Dayalbagh, Agra, although he was attended at that time by a well reputed Homœopath, who had been the President of the All India Homœopathic Conference.

The life of Dr. Verma was very simple. He never took any intoxicants in any form. He never used tobacco, cigarettes, Biri or tea and his food was very simple and nutritious. He was a God-fearing man and in the morning he did not do anything before reciting Bhagwat Bhajan. He was very particular and careful about the poor patients.

Whenever he visited a patient and came to know that he was poor, he did never charge even his visiting fees. Sometimes he did not also charge the car-hire rather he contributed something to the patient for the purchase of articles of diet. Many times the wretched conditions of the poor patients moved him to tears.

In Dr. Verma we have lost a philanthrophist and a Homœopath of high order. The only consolation to the people of Shahabad is that Dr. Verma has left behind his eldest son as the physician incharge of his well-equipped dispensary and the tradition of serving the sick selflessly.

Dr. Varma left this earthly place on April 24, 1955.
