THE FOUNDATION COURSE FOR LAYMEN

There is every good reason for the keen layman to be in on some of the secrets of medicine for his own good. The layman has to decide on his doctor. He hears both directly and by implication that he is free to choose any doctor since doctors are all alike. - 10. The Germ Theory. (And how it falls short.)
- 11. The Proving of Remedies. (No experimenting on the sick.)
- 12. Potentization of Remedies. (Homocopathy is unique here again.)

- 13. Homœopathy and The Modern Sciences.
- 14. Homæopathy-Post-Graduate Medical Specialty.
- 15. Preparation of The Homocopathic Physician.

Taken overall, this is fare for the mind that is nowhere else available, and most useful to the person who cherishes lasting health for himself and for those in his care, who relishes a good view of the medical and scientific landscape and wants a sound basis for judgment and action.
