CORRIGENDUM

No. 12-13/87-CCH (Pt. II).— In the Notification No. 147 dated the 25th September, 2003 of the Central Council of Homoeopathy published in Part-III, Section 4 of Gazette of India Extraordinary, the following corrections are made in the English Version, namely –

- In regulation 6 under Part (V), in the syllabus for Direct Degree Course, on page 69, the sign and word "& PSYCHOLOGY" may be added at the end in the heading "ORGANON OF MEDICINE AND PRINCIPLES OF HOMOEOPATHIC PHILOSOPHY", above the words "FIRST B.H.M.S".
- 2. In regulation 6, under Part (V), in the syllabus of ORGANON OF MEDICINE & PRINCIPLES OF HOMOEOPATHIC PHILOSOPHY, under (II) BHMS, under Section 1, on Page 73 in the heading "EVALUATION EXAMNATION", the word "EXAMNATION" may be read as "EXAMNATION".
- In regulation 6, under Part (V), in the syllabus of Anatomy, under the subheading of Neuro anatomy, on Page 84, in clause (e)(i), the word "Meanings" may be read as "Meninges".
- 4. In regulation 6, under Part (V), in the syllabus of HOMOEOPATHIC PHARMACY, on page 92, under Theory, in first para in Second line 'a' before the word "industry" may be read as "an".
- 5. In regulation 6, under Part (V), in the syllabus of HOMOEOPATHIC PHARMACY, on page-92, under Theory, at Part-1 the word "terminology's" may be read as "terminologies".
- 6. In regulation 6, under Part (v) in the syllabus of Homoeopathic Pharmacy, under Theory, at Part-1, on Page-93, in 4th line the word 'out' may be read as 'other'.
- 7. In regulation 6, under Part (V), in the syllabus of Homoeopathic Pharmacy, on Page 93, under Part II, under the heading of 'Homoeopathic Pharmacy in relation to', at (a) the word "on" may be read as "of".
- 8. In regulation 6, under Part (V), in the syllabus of Homoeopathic Pharmacy, on Page 94, under the heading 'PRACTICAL', at (2) (iii) the statement "Microsopic of two triturations of upto 3x potency" may be read as "Microscopic Study of two triturations upto 3x potency".

- 9. In regulation 6, under Part (V), in the syllabus of Homoeopathic Pharmacy, on Page 94, under 'PRACTICAL', at (4) the word "ethy 1" may be read as "ethyl".
- 10. In regulation 6, under part (V), in the syllabus of Homoeopathic Pharmacy, on Page 95, under the heading of 'PRACTICAL'; at (15) the word "manufacture" may be read as "manufacturing".
- 11. In regulation 6, under Part (V) in the syllabus of 'HOMOEOPATHIC MATERIA MEDICA", on Page 100, at 8(C), the word "Schuster's" may be read as "Schusler's".
- 12. In regulation 6, under Part (V) in the syllabus of "Pathology and Microbiology", on Page 111, under Practical; in the 1st paragraph, the word "aciedmeter" may be read as "acidometer" and thereafter the bracket may be closed.
- 13. In regulation 6, under Part (V), in the syllabus of "Pathology and Microbiology" on page 111, under Practical, in the 2nd paragraph, in the 2nd line, the word "faces" may be read as "faces".
- 14. In regulation 6, under Part (V), in the syllabus of "Pathology and Microbiology", on Page 113, under "KIDNEY BLADDER URETER URETHRA",in the 2nd line, the word "Pyolonephritis" may be read as "Pyclonephritis".
- 15. In Regulation 6, under Part (V), on Page 116, in the syllabus of "FORENSIC MEDICINE AND TOXICOLOGY", in the 1st paragraph, in the 2nd line, after the word "are" and before the word "be" the word "to" may be added.
- In regulation 6, under Part (V), on Page 116, in the syllabus of "FORENSIC MEDICINE AND TOXICOLOGY, under the heading of Medical Ethics, in the 3rd line the word "Malpractice's" and in the 4th line the word "legislation's" may be read as "Malpractices" and "legislations" respectively. In the same paragraph, in the last line the word "India" may be read as "Indian".
- 17. In regulation 6, under Part (V), on Page 116 in the syllabus of "FORENSIC MEDICINE AND TOXICOLOGY under the heading of "Forensic Medicine", in the 2nd line mummification's" may be read as "mummification".
- 18. In regulation 6, under part (V), in the syllabus of "FORENSIC MEDICINE AND TOXICOLOGY, on Page 117 under the heading of "Medico-legal Postmortem, in the last line of para, the word "ach" may be read as "each".
- 19. In regulation 6, under Part (V), in the syllabus of "PRACTICE OF MEDICINE", on under GENERAL GUIDANCE: THERAPEUTICS, on Page 121, in the 3rd para, in the last line, the word "PHOSPHRUS" may be read as "Phosphorus".

- 20. In regulation 6, under Part (V), in the syllabus of "PRACTICE OF MEDICINE", under the heading of GENERAL GUIDANCE: THERAPEUTICS, on Page 121 in the 5th para, the word "THERAPETUCIS" may be read as "THERAPEUTICS".
- 21. In regulation 6, under Part (V), in the syllabus of "SURGERY", on Page 125, the heading of "OPHTHAMOLOGY" may be read as "OPHTHALMOLOGY".
- 22. In regulation 6, under Part (V), in the syllabus of "SURGERY", under the heading of Management of Common SURGICAL PROCEDURE AND EMERGENCY PROCEDURES, on Page 126 at No. 8 the word "Hemorrhage" may be read as "Haemorrhage".
- 23. In regulation 6, under Part (V) in the syllabus of "SURGERY", on Page 126 under the heading of "EXAMINATION", in Paper-1, the word "Hemorrrhage" may be read as "Haemorrhage".
- 24. In regulation 6, under Part (V) in the syllabus of "SURGERY", on Page 126 the heading of "EXAMINATION", in Paper-II the words "Abdominal Surgical", may be read as "Abdominal Surgeries".
- 25. In regulation 6, under Part (V) in the syllabus of GYNAECOLOGY & OBSTETRICS INCLUDING INFANT CARE on page 129, under PRACTICAL & CLINICAL EXAMINATION, in the 1st line the word "on" may be read as "one".
- 26. In regulation 6, under Part (V), in the syllabus of COMMUNITY MEDICINE on Page 131, under Preventive Medicine, at (a) in the 1st line the word "diseased" may be read as "diseases".
- 27. In regulation 6, under Part (V), in the syllabus of REPERTORY, on Page 132, under b, at 3 the word "terminology's" may be read as "terminologies".
- 28. In regulation 10, in clause (ii) at page 138, the word "First" coming between the word 'Fourth' and the nomenclature BHMS may be omitted.
- 29. The Note given at the end of these regulations may be read as under -
 - "Principal regulation were published in the Gazette of India, Part-III, Section 4 on 11.5.1983 and subsequent Corrigendum was published in the said Section of the Gazette on 6.2.1984."
